

SECOND PHOTOGRAPHY COMPETITION

CELEBRATING DARIO FUSARO

The competition was created to celebrate the talented photographer Dario Fusaro, who recently passed away. Fusaro always found inspiration in nature and the places he explored, and this competition is a way to honor his artistic legacy.

The photography competition invites all photography enthusiasts to capture the beauty of gardens, both public and private, at any time. The theme of the competition is **"The Garden in the Four Seasons"**.

We invite participants to interpret this theme personally, exploring the beauty of places, light, colors, and the emotions that gardens can evoke.

REGULATIONS

Art. 1 RECIPIENTS AND DEADLINE

Participation in the Competition is free and without any citizenship limitations. Competitors of any nationality or residence must be of legal age by the deadline for submitting photographs, which is strictly set for the end of the day on **September 18, 2026, by 00:00**.

Art. 2 PARTICIPATION PROCEDURES

Participation is strictly individual and reserved for natural persons – including professionals – as the formation of working groups, or the presence of companies or corporations constituted in any legal form, is not permitted for this purpose. Participation in the Competition is free and only requires the complete filling out of the regulations and the application form. These forms in PDF format, together with the required materials, must be sent by the date set by Art. 1 to the following e-mail address solely in digital format via "e-mail" or "WeTransfer".

Art. 3 PRODUCTION METHODS AND CHARACTERISTICS OF PHOTOGRAPHS

The photographic works must be original and taken by the participant, captured live, and presented solely in digital format; they can be created with any instrument capable of recording via a digital sensor.

Each participant can submit a maximum of 3 photographs. The images must be sent in digital format (JPEG or PNG) with a minimum resolution of 300 dpi and a maximum size of 10 MB.

The "file" containing the image must be identifiable by:

- Competitor's details: Surname and Name;
- Caption of the work: Title, year.

Art. 4 EVALUATION CRITERIA

The works will be subject to evaluation by a qualified selected Jury; they will be analyzed both in their overall unity and in detail. The following evaluation parameters will be used in particular: adherence to the theme, originality, compositional quality, methods of definition and description of the iconic space, expressive characteristics, methods and quality of communication, presence of symbolic and/or cryptic elements, etc. Works that, in the unquestionable judgment of the Jury, present content deemed inappropriate due to the nature of the representation of contexts, facts, and/or concepts contrary to the law, will be excluded from the evaluation and therefore from the Competition. Any responsibility for such disclosures falls entirely on the competitor. The Jury, while attentive to detecting instances of plagiarism, is not responsible for the occurrence of such events, the sole responsibility for which falls on the participant in the Competition, who expressly indemnifies the Jury and the organizer.

Art. 5 JURY AND PRIZES

The Jury will be composed of industry experts and magazines with which Dario Fusaro worked and will evaluate the works based on creativity, originality, and the ability to convey emotions through the landscape. The Jury's judgment is unquestionable and discretionary, albeit within the parameters indicated above.

Prizes:

1st Prize: Only one absolute winner will be selected, whose shot: Will be published in the special issue of the Lineaverde GreenItaly magazine distributed at the fair and a commemorative plaque of the competition.

Special Recognitions:

- **2nd Prize (special mention):** Inclusion of the photograph in the Lineaverde GreenItaly magazine and a commemorative plaque of the competition.
- **3rd Prize (special mention):** Inclusion of the photograph in the Lineaverde GreenItaly magazine and a commemorative plaque of the competition.

Other Recognitions:

The top 10 ranked photographs will be published on the official social channels of the event. Furthermore, the selected works will be presented within an exhibition dedicated to Dario Fusaro, where the author's photographs will be projected alongside those of the participants. Conversely, the Jury reserves the right not to award one or more prizes if it believes that the participation has not been able to express the quality levels expected by the Jury itself.

Art. 6 AWARD CEREMONY

The Award Ceremony will be held on **October 8, 2026**, on the occasion of GreenItaly, at Fiere di Parma. During this event, through the system, in addition to the winning photographs, those images deemed by the Jury worthy of being selected will be projected, as well as a gallery of photographs by Dario Fusaro.

Art. 7 INCOMPATIBILITY

All natural persons who have direct ties with Lineaverde GreenItaly, which promotes the competition, are excluded from participating.

Art. 8 RIGHTS

Each author is personally responsible for the works submitted and formally declares, by participating in the Competition, that they have obtained the necessary authorization for the creation and use of images containing people and/or things for which it is necessary to obtain specific consent according to the Copyright Law.

Participants in the Competition guarantee that the content submitted does not contain illicit materials prohibited by law or contrary to what is indicated in this announcement; they also declare that they are aware that civil and criminal responsibilities for the content of the creative proposals submitted for participation are their sole and exclusive responsibility, indemnifying from now on Lineaverde GreenItaly, the Jury, and Fiere di Parma S.p.A. from any third-party claims, and therefore Lineaverde GreenItaly, the Jury, and Fiere di Parma S.p.A. will not be in any way responsible for any claims for damages advanced by subjects present or involved in the submitted proposals.

Art. 9 VISIBILITY OF WORKS AND USE OF MATERIALS

Lineaverde GreenItaly (and consequently Fiere di Parma S.p.A.), as the promoter of the initiative, avails itself of the right of permanent use and free publication of the received works, citing the authors' names. The materials may be used for promotional, non-commercial purposes, without further consent from the author, who also declares, by accepting the terms of participation contained in this Announcement, to be the sole owner of the related rights, thus freeing Lineaverde GreenItaly from any responsibility towards third parties.
